PARTICIPANT AGREEMENT, RELEASE, AND ASSUMPTION OF RISK

In consideration of the services of PRESTON PUBLIC SCHOOLS and Jumpin' Jiminy Inc, their agents, owners, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release, indemnify, and discharge PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that riding inflatables entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Furthermore PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc from any and all claims, demands, or causes of action, which are in any way connected with my participations in this activity to my use of PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc's equipment or facilities, including any such claims which allege negligent acts or omissions of PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc.
4. Should PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc I agree to do so solely in the state of Oklahoma and I further agree that substantive law of Oklahoma shall apply in that action without regard to the conflict of the law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against PRESTON PUBLIC SCHOOLS and Jumpin Jiminy Inc on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
